1/23 Erasmus+ staff mobility routines

Senior advisor at the international office Ida Charlotte Jakobsen gave a brief introduction to the case. To increase the numbers for staff mobility its important to look at the routines and make the process of applications more predictable and more efficient.

50% of the allocated budget is earmarked for SEA-EU mobilities, and these funds do not have a set application deadline.

The members were asked to comment on the suggestion, one question was asked about whether or not the priority list from the faculties need to come from the Faculty Director. The sentence in the routine description will be changed to point out that it does not need to be sent by the Director, but the priority list needs to be approved by the Faculty management before it is sent over to the International Office.

2/23 Erasmus+ staff mobility: status applications January 2023

There was 45 applications for Staff mobility in this application round. 65% of the applications was for a mobility to one of the partners in SEA-EU.

The members were asked to comment, no comments were made.

3/23 Application numbers Study and Placements Abroad

Senior- executive officer at the International Office Kai-Martin Johnsen gave a brief presentation of the numbers of applications for studies and placement abroad. There was a total of 225 applications.

Most students apply to an Erasmus+ partner.

There were 12 applications for placement/Internships.

There were 64 applications for placement abroad in the nursing field.

Levi Gårseth-Nesbakk asked for more information on what kind of placements or internships the student are applying for, and why there is such a big difference in the numbers between the campuses. It was mentioned that the study programs in Vesterålen are part time, with historical low numbers which might be a result of a particular group of students taking this study programme. A comment was made by one of the student representatives that promotion of student exchange at Mo i Rana needs to improve.

A comment was made that the case should have presented how this year's numbers are in comparison to earlier years. This will make it easier to tell if we are heading in the right direction when it comes to student exchange.

Ragnhild Forseth from the Faculty of education and arts gave some notes on why the numbers from their faculty is lower this year.

There will be given more information on this in the meeting in March.

4/23 Working group: ranking criteria incoming and outgoing student mobility

Senior advisor at the international office Ida Charlotte Jakobsen gave a brief introduction to the case. The aim is to establish institutional ranking criteria for both incoming and outgoing student mobility.

In general, institutional ranking criteria are welcomed, but it should include faculty-specific conditions. It also needs to consider weighted average. FSH and FBA signed up for the working group and will be included moving forward. A question was raised by a student representatives about how this is done at each faculty today. To map out the different routines for selection is part of the working groups tasks. Each faculty's routine will be assessed to come up with a complete draft for institutional criteria.

A draft will be shared with all faculties to allow input, and the working group will present the final draft in the International Committee meeting in June.

5/23 Implementing Tuition fees

Director of Student and Academic Affairs, Anne Ringen Pedersen, and Head of Finance and Analysis, Per Arne Skjelvik joined the meeting to present how Nord University are working on a proposal for tuition fees. It has been difficult for the sector to set a price and agree on the right price model. It is concluded that the sector will set prices according to the "financing categories" of the Ministry of Education and Research. Institutions in Norway are not obliged to follow this model, but most of them have decided to do so. University of Stavanger has decided not to follow this model. A total cost model is rather complex and is not recommended for 2023. The proposed model is recommended for the next two years before revising the issue.

The "finance categories" of the Ministry of Education and Research

This means that at Nord University the tuition fee will be approximately from NOK 65.000 – 90.000 for each semester.

- Bachelor of Circumpolar and Nordic Studies (Partly online), NOK 65.000 each semester
- Bachelor of English, NOK 65.000 each semester.
- Bachelor of Science in Biology, NOK 80.000 each semester.
- Film and TV Production, Bachelor's Programme, NOK 90.000 each semester.
- Games and Entertainment Technology, Bachelor's Programme, NOK 90.000 each semester.

Please note that these are the expected rates. They are subject for change and not final.

Tuition fees does not apply to students outside the EU/EEA that have already started their degree at Nord University, or students that comes for an exchange semester.

A working group at Nord University are still working out all the details regarding the practical matters. An email will be sent out to all students who have applied within the deadline, with an estimated costs for the study programme that they have applied for. All of them will have the opportunity to withdraw their application.

6/23 SEA-EU status report meeting 1/23

SEA-EU project manager, Tove Holm, entered the committee meeting to introduce herself and present a status report for SEA-EU.

There was also given some information about the kick off in Cadiz, Spain 6-10. February 2023. During the visit the partners was focusing on staff weeks. Nord University has a goal to arrange one staff week for teaching and one staff week for non-teaching per year.

Student representative Anna Viktoria Bjørsvik participated in Cadiz. She gave a short summary of the work she took part of along with student from the other SEA-EU partner universities. The students discusses strategy, moving forward, how to conduct meetings, and did some creative thinking.

On the 15th and 16th of March Nord University will be hosting a partner visit from the University of Cadiz. Bodø municipality will host one of the meetings om March 16th.

7/23 Revision of mandate and constitution of the International committee

Senior advisor at the international office Ida Charlotte Jakobsen gave a short introduction to the case.

Ragnhild Forseth: FLU will give feedback on the mandate at a later time after discussing it locally.

There was a brief discussion on how the mandate should be seen in collaborating with the mandate of the research committee and what cases should be brought up in the International Committee.

Prorector Levi Gårseth-Nesbakk stated that the international committee should be action based and create engagement. It's a good thing to have a more practical approach in the mandate.

To follow up on the work with the mandate, the draft will be sent to all faculties — with track changes. It will be followed up in the Committee's meeting in March, with the aim to have a complete draft ready to be presented in the June meeting.

8/23 Blended Intensive Programmes (BIPs) - status report 2022 - 2023

Advisor at the international office Elena Popova gave a brief summary of the case.

Most of the BIPs are 3 ECTS, which is the minimum requirement. This proves difficult at Nord University, because we do not have many courses with only 3 ECTS. How can this be implemented?

The International Office must be informed by February 20th if the faculties at Nord will coordinate one or several BIPs within the SEA-EU consortium during 2023/2024.

9/23 Partner visits to Nord March 2023

Orientation was given about the delegation from the French Embassy coming to visit Nord 7-10th of March 2023. Faculties were asked to fill out the spreadsheet in Teams and to plan their individual meetings accordingly

10/23 International Week 2023

Orientation about the status of the work on International Week. The group has not had any meetings after Christmas yet, but are starting up again now. The ambition is to develop an annual international week, in October each year. It is meant to be a physical event in Bodø and Levanger, but also include the other study locations. Target group is not necessarily only

students, but also staff. The working group have an idea to connect this work to the planned Staff Weeks in SEA-EU and will reach out to the project manager in regards to this.

The working group want to start sending out "save the date" to our partners, and invite them to participate – at own cost. The working group will also send a heads-up to all staff/students at Nord University early so that they can get it in the calendar early.

11/23 Budget 2023

No changes to the budget is expected from the University Board. The budget include all basic operating costs for the International Committee. The financial support to ISU Bodø is paid. No update yet on the establishment of ISU Levanger.

12/23 Protocols from the local international committees, meeting 1/23

Protocol from the Local International Committees – only FSV was attached. International coordinator at the faculty of Social Sciences Stian Hiis Bergh gave a brief summary of the protocol.

13/23 Updates and reports on internationalization from students and faculty

HHN: currently in Singapore to meet with the Chinese partners. Working on the action plan in the local IU.

Student representative SOB: SOB has arranged "Studenttinget", a student democratic arena. They discussed opt out. Will share the protocol of this with the working group on opt out to consider the student voice on this.

ERASMUS+ STAFF MOBILITY GRANTS: CALL FOR APPLICATIONS MAY 2023

Forslag til vedtak:

The International Committee approves the coming call for applications for Erasmus+ staff mobility grants

Sammendrag

Nord University has two annual call for applications for Erasmus+ staff mobility grants. As the priorities for allocation in each call may vary, the International Committee must agree on the priorities in advance.

Saksframstilling

The following is proposed for the call for applications in may 2023, with application deadline 1st of August 2023:

Erasmus+ mobility grant for staff at Nord University

Nord University is allocated funds for European Countries (EU/EEA, as well as Serbia, North-Makedonia and Turkey). Members of staff at Nord University can be awarded grants for work-related travels to these countries.

All members of staff at Nord University are eligible to apply for an Erasmus+ grant, regardless of type of employment or department (except PhD-candidates, who are encouraged to apply for Erasmus+ student grants).

The grant amount varies according to length of stay and host country. Any incurring travel costs exceeding the grant amount must be covered by the employee's department at Nord University, and therefore Erasmus+ grants is only awarded for travels that are approved by relevant office manager.

The following will be prioritized in this call:

- Mobility to existing partner institutions
- Mobility that contributes to (increased) student mobility
- Mobility that contributes to increased competency within the employee's area of responsibility
- Mobility that contributes to increased intercultural competency and improved language skills at the individual level
- Mobility that contributes to

Additional criteria:

- Length of stay: 2-5 days, plus up to two days of travel where relevant
- Applicants must have a minimum position of 50% at Nord University
- Applicants must fill out details of planned activities during mobility in relevant Mobility Agreement and attach to their application form
- Period of travel: from 1st of September 2023 to 1st of March 2024.

Selection process:

 Applicants will undergo an internal prioritization process at their department at Nord University, and the International Office will make allocations based on the priority made at each department Applicants will get a response to their application no later than 4 weeks after application deadline

COMPETITIVENESS

Bakgrunn

The implementation of tuition fees means the higher education sector in Norway will have to change the way we think about recruitment of international students. We have to be competitive on the international educational arena, but also with regards to other Norwegian institutions.

The International Office gets an increasing number of questions about courses and programs in English. The inquiries come from both students from partner universities and free movers. Most of the students are asking for more courses and exchange opportunities within faculties for regular and kindergarten teaching, as well as nursing education. Students are also asking for courses at the other faculties. In addition to single courses and semester packages the international office get inquiries asking for additional master and bachelor programs. At the moment Nord only offers 4 master programs in English (two at the Business School and two at the Faculty of Biosciences and Aquaculture), and 6 Bachelor programs.

REVISION OF MANDATE AND CONSTITUTION OF THE INTERNATIONAL COMMITTEE

Forslag til vedtak:

The International Committee makes note of the orientation.

Sammendrag

The secretariat of the International Committee, the Director of Academic and Student Affairs, and Prorector Education have had meetings to evaluate the International Committee and discuss how we can strengthen the activity within the committee and what it is supposed to deliver on.

As a result of this, we will revise the existing mandate and discuss how the composition of members in the committee should be constituted.

The International Committee will together revise the mandate, and a final draft for the new mandate and constitution shall be ready by the end of spring semester 2023. The committee will operate under a new mandate from autumn 2023.

Saksframstilling

A first draft of the mandate was presented in the committee meeting in February, and a brief discussion followed. To follow up on this, the drafted mandate, with track changes, was sent out to all faculties and student representatives in order to get feedback.

The following new mandate is proposed:

- 1. The International Committee is an advisory body for Nord University's management in all matters pertaining to internationalization (in education and research)
- 2. The International Committee shall establish and implement measures to (contribute to increased quality in education through) increase(d) internationalization at Nord University
- The International Committee shall develop action plans and report to the university's management on activities that stimulate to the realization of the university's strategic objectives on internationalization
- 4. The International Committee shall advice Nord University's management on allocation of strategic funding for internationalization
- 5. The International Committee can make decisions when at least half of the constituted members/deputy members are present

The International Committee is constituted by 10 members, selected for the academic year 2022/2023 and Prorector Education is the leader of the Committee. The members are currently all administrative staff (except the three student representatives). In the context of the revision of mandate, it is also necessary to discuss how the committee shall be constituted, in order for the committee to be more action based and create engagement to a larger extent.

- 5. internasjonalt utval er vedtaksført når meir enn halvparten av medlemmene er til stades og gir si stemme. Dette inneber også varamedlemmer dersom faste tilsette ikkje har høve til å møte.

Internasjonalt utval handterer dei sakene som gjeld internasjonale studium/studentutvekslingar, utvikling av samarbeidsavtaleporteføljen, og fagleg/administrativ kompetansebygging og mobilitet.

Saksframstilling

Nord University/International Office submitted an application Erasmus+ funding for mobility within Europe (Key Action 1, KA131). We applied for 29% increase in mobilities in total, which includes a double increase of staff mobilities. Nord also applied for organisational support for coordinating five BIPs.

The institutions apply only for a certain number of mobilities in the application form, but not for a funding amount. This means that, given the varying length, type and funding of the mobilities, the awarded budget may not be corresponding to the budget needed to actually implement the planned mobilities at the applicant institution. For this reason, the applicant institutions are required to upload an attachment to the application explaining their planned activities, which helps HK-dir assess the budget needs of the institutions. HK-dir allocates funding on the basis of past performance - mobility goals reached and budget utilized.

Erasmus+ projects have a duration of 26 months and this makes it possible to have a budget overlap of two projects. Nord will be using funding from the project awarded in 2022 to cover a large part of the mobility taking place in 2023/2024. The funding awarded through the 2023-project will be a supplement for 2023/2024 activity and can cover activities in 2024/2025 as well.

HK-dir is expected to finalise the assessment of the applications and allocate mobilities and funding to the institutions by the end of April or beginning of May.

It is important to note that this action does not support mobility of first or second cycle students from a Programme Country (Norway) to any Partner Country that are recipients of official development assistance (ODA).

Nord University applied for 4 different mobility projects this round;

- Faculty of Nursing and Health Science for <u>staff mobility</u> with Augustana University,
- Faculty of Social Sciences for <u>staff mobility</u> with Institut Supérieur de Travail Social, Catholic University of Madagascar, Madagascar
- Faculty of Bioscience and Aquaculture and the Business School, for <u>student mobility</u> (<u>incoming</u>), <u>PhD mobility and staff mobility</u> with three institutions in Brazil (State University of Campinas (UNICAMP), São Paulo State University (UNESP) and Federal University of Espírito Santo (UFES))
- The Business school for <u>PhD and staff mobility</u> with two institutions in South Africa (University of Pretoria (UP) and University of Stellenbosch (SU)).

In total, Nord University applied for a total grant of 345 275 EURO. Announcement of allocation is expected in June.

Although the application involves several mobility projects, it is sent as one institutional application from the International Office on behalf of Nord University. The application is a qualitative application, which means that the application process requires a collaboration between the International Office and the Faculties, and the partner institutions. This application round has shown that it is necessary for the International Office to establish a routine description for future applications. This will be done well ahead of next year's application round.

Saksframstilling


The International Office is responsible for the admission of incoming exchange students (semester students) twice per year (spring semester and autumn semester). Together with faculties and partner universities, the International Office is preparing for a new exchange intake for the Autumn 2023 semester. The deadline for the Autumn nomination and yearlong exchange are **April 1**, and the deadline for the Autumn application and year-long exchange are **April 15**.

This year, the International Office is piloting a project with selected university partners in order to increase administration efficiency in the nomination and application stages. Mari Vang Johansen is working on this in the Nomination Web and the Application Web. Hopefully this would eliminate short-term and long-term operational bottlenecks, such as miscommunication, lost documentation, or backlogged work. However, since the new system is not put in place yet, this leads to manual processing for the Spring 2023 intake.

The International Office have sent nomination links to 141 partner institutions worldwide. Though we have yet to collect all responses from the institutions, some institutions have sent their nominations.

As per March 9, 2023, there have been 59 nominations and 22 applications. The incoming students vary from the European Union and North America, as shown by the chart below.


COUNTRY OF ORIGIN - INCOMING EXCHANGE AUTUMN 2023

Saksframstilling

The working group on International Week has decided that the main focus of this years event will be to create engagement and to make the event known in the organization. The goal is to engage students and staff in internationalization, give information on mobility and to promote the possibilities in the SEA-EU.

Mari Anna Brønseth Friedrich from the International office and Kristin Aaknes from the Faculty of Education and Arts had a meeting with the project manager in SEA-EU, Tove Holm early in March. SEA-EU Nord is planning for staff weeks and international weeks within the work packages of SEA-EU, but this will most likely not be effectuated before in 2024. The SEA-EU will contribute with information at international week 2023, and will try to plan all partner visits this fall to the dates for international week.

The working group has asked the international coordinators at faculty to inform the Deans about the date, time, place and how the event should be communicated to all staff. The working group has also asked the coordinators to challenge the faculty leaders on what type of activities the faculty think is relevant for their staff. It is important that the faculties take ownership of this opportunity to establish internationalization as a key priority for students and staff at the University.

EVALUATION STAFF SEMINAR INTERNATIONALIZATION

Forslag til vedtak:

The International Committee makes note of the orientation.

Sammendrag

Nord University's staff seminar on internationalization is an action rooted in the Action Plan for Education 2021-2025 and is part of the annual strategic cycle of the International Committee.

This year's seminar was held on Wednesday 15th of February at Campus Bodø. Staff from all faculties and units at Nord University came together to discuss current affairs in internationalization; Joint degrees, opt out and tuition fees.

The aim for the seminar is to create engagement for internationalization, as well as to spread knowledge and strengthen internationalization at Nord University.

Saksframstilling

The topics for this year's seminar were joint degrees, opt out, and tuition fees.

Prorector Education presented the ambitions for joint degrees in SEA-EU, while the Business School and the Faculty of Bioscience and Aquaculture presented examples on how to develop a joint degree. The International office presented Nord University's pilot on opt out, and the International Student Union presented the student perspectives on introduction of tuition fees for students outside EU/EEA. Each topic also included a group discussion (comments attached).

The staff seminar working group sent an evaluation form to everyone that registered for the seminar to get feedback in order to improve future seminars. Only 11 out of the 43 registered staff did respond to the evaluation form, and 26 of the registered staff attended the seminar.

The respondents said that they received information about the seminar by email, the intranet, from colleagues, and posters in the lunch room.

72% attended the entire seminar. Those attending only parts of the seminar, attended the topics about tuition fees and/or Joint Degrees

80% of the respondents was satisfied about how the seminar was organized, and 70% was satisfied with the information ahead of the seminar.

60% was satisfied with the topic and presentation - Joint Degrees Comments:

- Relevans for gruppen som møtte...?
- The content was good. I wish there was more time in the schedule about Joint Degrees.
- Some were a bit too detailed.
- I did not know the exact definition of joint versus multiple degree. That is useful for me as SPA of the Nordic Master which involves partner universities

60% was satisfied with the topic and presentation - Opt-Out

- The group discussion where interesting.
- Good discussions

80% would recommend colleagues to attend future staff seminars about Internationalization

Suggestions about topics for future seminars:

- Funding opportunities (NORPART, UTFORSK, INTPART, etc)
- Would like to discuss practical issues about student and staff mobility. For example where students can go for mobility, active agreements etc., There is information on the intranet but some of the information is old and doesn't apply any longer
- Relevans for de som møter må løftes. Praktiske spørsmål av interesse og mulighet for å gjøre noe med.
- The timing for each presenters could've been better so that the time allocation is equal to each presenter. Maybe using a timer and a reminder for each speaker would help to fix this issue.
- project management; more on internationalization; gaining synergies in the work between uni faculties
- more about regulations and stay (3 months) BIP
- integration and language courses for international employees

54% would like to join the working group for future seminars.

Other Comments:

- The student representative's presentation on what international students value was interesting and informative.

Comments from group discussions

Group discussion on topic 1; joint degrees

Q1: Reflect on the case of Blue Economy: Challenges in developing a joint degree

- The main challenge will be the way the courses are taught and evaluated in different universities. How will they be evaluated by NOKUT?
- Significant resources are needed to run a join degree. Funds needs to be allocated to cover costs associated with developing and running new courses. Task management can get confusing as to who is responsible for what.
- Agreeing on important items, management of programs, cultural and national differences
- Degree of politeness, time punctuality

Q2: Reflect on the case of Blue Economy: solutions to overcome challenges in the development of a joint degree

- NOKUT might be a natural partner to solve these
- The administrative costs will be raised through having smaller ECTS courses. Funds needs to be allocated in connection with the paperwork that joint degrees require. A clear outline of tasks and who is responsible for them will help with the administration and running of a joint degree
- Possible solutions: making a written document that can be accessible for every partner in different time zones. This document would contain some guidelines on terms of agreement, institutional differences and national/cultural differences

Group discussions on topic 2; opt out

Q1: How do you understand opt out?

- The students have to choose NOT to travel. The main study plan is "you are going to travel". It makes the students think about exchange in a serious manner
- Opt out can be defined as an act when a student take back his/her application from the student exchange application
- That there is an expectation of exchange, and the active choice is to reserve oneself from the opportunity

Q2: Discuss potential challenges with implementation at Nord University

- Length of exchange on the academic side, BIPs are seen as a viable option for exchange, and for FSH, the increase in applications was significant. However, BIPs are not currently part of the statistics of exchange. Opt out then needs to be considered also for short stays abroad, not just an entire semester. Language requirements can be a barrier in several universities, even if the students are meant to do their placements in English.
- There is no guarantee to find a similar study program abroad. Need to separate between exchange for placements and for courses different challenges
- Lost credits if we cannot host as many students as we send out. Do we need to offer more English taught courses? This has a cost
- Challenge 1; enough place for students to do an exchange program, challenge 2; a
 disconnect between policy vs. practice, challenge 3; Exchange programs look
 different in different study programs, challenge 4; cultural and institutional
 differences in securing mutual understanding for exchange programs

- Different study programs attract different types of students (homebound vs. outgoing)
- If we expect students to go abroad, our product (for exchange) needs to be of high quality. This is not the perceived case today. Information available to students should be relevant and inspiring, clear and accurate, easy available and updated. Packagedeal in international perspective.

Q3: Discuss potential solutions

- A summer programme may be a viable option for exchange, not just an exchange during a semester. This could be combined with a BIP programme. It would be ideal for the government to consider short-term exchange in their statistics. Signing enough agreements with compatible educational institutions is a necessity for opt out.
- More digital communication/digital lectures across boarders
- To lower the threshold to go on exchange, to get to know international institutions and English as a teaching language, use of digital communication and digital lectures.
- Solution 1; customize the exchange programs within existing study program, taking into consideration the laws and regulations that apply for such programs, solution 2; involve students with international at home activities, such as online based programs, blended mobility with EU partners through Erasmus etc. solution 3; tighter communication between the faculties, the education committee, the students, and the international office when it coms to administration and the practical matters of the programs
- Does not need to be a full semester. Create short term blocks.

Group discussions on topic 3; tuition fees

Q1: What will tuition fees for international students outside EU/EEA mean for the way we work with internationalization?

- The way we design, deliver and market out programs need to change
- Internationalization will definitely need to be more targeted to specific groups and countries. It is obviously going to be easier to recruit students inside the EU/EEA, which means we should find a way to appeal to them more, to work with their needs and their expectations.
- We might end up in less research, less networking, and less international collaborations
- It would make it more difficult for us to work with internationalization because we know that everything hangs on the financial foundation. Especially because there has not been a discussion on scholarship or other alternatives such a subsidizing the study programs. This would be a hindrance in realizing Nord's internationalization efforts immensely. However, this could also present itself as an opportunity, especially for the internationalization at home efforts
- We contribute less to the global society's development than before. Education is one of the most important tools for societal development
- If due to fees we have less students then it will effect the education programs? DO we have to chose some programs? I am curious to know

Q2: How should we work to ensure that we attract this group of students, when education no longer is free (for them)?

- We can point out how different their experience will be, how studying abroad itself
 can change you and broaden your views and even in the moment they might have to
 go back, they will do so with a different view on things and understanding of life that
 they can get in Norway or more specifically in Bodø

- Idea 1; We can boost alumni programs as a free marketing tool. Idea 2: we can develop a closer student-teacher cooperation in study programs, idea 3: we should try to find other income, for example using Bachelor's program of Journalism and the communication department to come up with a money-making idea to showcase the uniqueness of Nord University, Idea 4; helping international students to secure part time jobs and to prepare themselves for the working life, together with the career center.

57/2022 Vedtakssak: Handlingsplan 2023

Saksfremstilling:

Leder og representant for administrasjon har tatt utgangspunkt i handlingsplanen for 2022 og laget et revidert utkast for året 2023. Dette er gjort på bakgrunn av kommentarer på møte 5 i oktober. Utvalget var enige om at det måtte ha mer fokus på akkreditering av HHN og nettverksalliansen SEA-EU og hva utvalget kan bidra med.

Utvalget kommenterte at samarbeid med partnere i SEA-EU er ikke selvinnlysende ut fra tilbudet de har. Det er viktig at vi identifisere eksisterende muligheter og lager nye muligheter og synergier med partnerne.

For å øke ansattmobilitet så må det komme mer info på nettsiden vår, og ikke kun intranett. Vi må kunne vise våre interessenter at vi jobber internasjonalt, vi har godt samarbeid med andre institusjoner i utlandet, vi har gjesteforelesere og vi selv besøker andre universiteter der våre gjestelesere gjerne kommer fra. Et eksempel på hvordan det kan gjøres er på studieprogramsidene er det ofte artikler om studenter som har fullført det studieprogrammet og som forteller om yrkesveien deres videre. Her kan vi også ha artikler om en foreleser på det studieprogrammet som har vært på besøk hos en partneruniversitet og forelest der. Potensielle nye studenter vil lese om internasjonalisering av studieprogrammet og våre ansatte. Våre ansatte vil lese om erfaringene til den enkelte som har vært på reise og kan bli nysgjerrig på å søke på ansattutveksling selv.

Utvalget har snakket om måter vi kan dele informasjon om AACSB akkreditering når det arbeidet settes i gang for fullt. Et forslag var å bruke Hubro. Leder for utvalget har brukt dette i sin undervisning og har forespurt Hubro om muligheten til å bruke det til et slikt formål. Hubro informerte at ingen andre institusjoner har brukt det til denne type informasjon før så da må det lages noe nytt. Hvis HHN er interessert så kunne Hubro komme med en kostnadsestimering.

Med bakgrunn i diskusjonen til utvalget er det kun småjusteringer av enkelte presiseringer og språk som ble endret i handlingsplanen. Dokumentet sendes til designer på HHN for å lage en profesjonell utgave av den. Den vil deles med utvalget når den er ferdig.

Saksfremstilling:

Utvalget hadde sitt første møte på Steinkjer i mai 2022 og har planlagt tilnærmede møter for Mo i Rana og Stjørdal våren 2023. 60/2022 Orienteringssak med diskusjon: Skolepenger for internasjonale studenter utenfor EU/EØS

Saksfremstilling:

I statsbudsjettet for 2023 har regjeringen foreslått å innføre studieavgift for studenter som kommer fra land utenfor EØS og Sveits. Forslaget vil gjelde fra og med høstsemesteret 2023. Avgiften skal minimum dekke kostnadene til utdanningsinstitusjonen og vil gjelde for <u>nye studenter</u>. Høyere utdanning vil fremdeles være gratis for norske studenter og andre EØS-borgere. Studieavgiften vil gjelde de som tar hele utdanningen i Norge som betyr at utvekslingsstudenter vil ikke betale studieavgift. Statsbudsjettet for 2023 vil bli vedtatt i Stortinget i midten av desember 2022.

Utvalgt diskuterte erfaringer, mulige konsekvenser og forslag til å få nye studentgrupper til å søke til HHN.

Etter at Sverige innførte studieavgift erfarte de at de kun fikk studenter som var motiverte til å studere. Institusjonene hadde tidligere utfordringer med internasjonale studenter som kom hovedsakelig for å jobbe.

Hva kan vi gjøre for å fremdeles være synlig på markedet? Hvilke mekanismer kan vi bruke for å få flere studenter? Kan vi tilby mer digitale emner? Hvilke tiltak kan vi gjøre for å sikre at vi fremdeles får studenter fra strategiske partnere og partnere der vi har gradssamarbeid utenfor EU/EØS? Hvordan har kommunikasjonen internt på Nord universitet vært så langt og hvordan er prosessen videre planlagt? Dette var noen sentrale spørsmål som ble tatt opp i utvalget.

Utvalget ser utfordringene med internasjonalisering som introduksjon av studieavgiften vil medføre. Vi ser også at dersom det innføres så må vi være proaktive og se hvordan vi kan tilrettelegge for å få studenter utenfor EU/EØS eksempelvis ved å gi stipend. Blir studieavgiften innført må vi se etter mulige løsninger so vi kan fortsette å jobbe aktivt med internasjonalisering.

Saksfremstilling:
