

Admission and Requirements Double degree

Master of Science in Business

Admission to our Master of Science programs is based on a Bachelor degree of four years of study (Bachelor or equivalent) in business/management-related fields, with certain requirements concerning relevant courses. Minimum **90 ECTS** credits within the following topics must be covered as part of the undergraduate study:

Business 30 ECTS credits (introduction to business administration, management accounting, financial accounting, finance and investment)

Administration/Management 25 ECTS credits (organization, marketing, strategy, management)

Economics 15 ECTS credits (microeconomics, macroeconomics, public finance)

Methodology 20 ECTS credits (statistics, mathematics, scientific method)

Admission requires a good result (laudabilis). For international students minimum 2nd Class, Upper Division/B or equivalent is required.

The deadline for applying is **December 1**st.

Required documents Ukraine (NOKUT)

Nord University follows the GSU-list set by NOKUT (Norwegian Agency for Quality Assurance in Eduction). The GSU-list contains information about basic admission requirements for admission to higher education in Norway (https://www.nokut.no/en/surveys-and-databases/nokuts-country-database/GSU-list/).

In addition, we follow NOKUT's documentation requirements: Applicants to Nord University are subject to documentation requirements provided by the Norwegian Agency for Quality Assurance in Eduction (NOKUT). The requirements are country-specific, meaning that they vary depending on where applicants obtained their education and qualifications. The required documents for Ukraine is listed below:

Secondary education:

- Atestat pro Povnu Zagalnu Srednju Osvitu / Атестат про повну загальну середню освіту + 1 year university education OR
- Диплом молодшого спеціаліста /Diplom molodsjogo spetsialista can be assessed individually for the Higher Education Entrance Qualification



From higher education:

- A four-year bachelor degree
- Diploma Supplement (if available)

Other documents:

- Translations. All documentation must be translated, unless in English, Swedish, Danish or Norwegian. The translation must be carried out by a government-authorised or otherwise accredited translator. You must include a copy of the original document.
- Documentation of name change (if applicable)

Apostilles

NOKUT requires that documents of higher education issued in Ukraine are apostilled under the current rules set by the Ministry of Education and Science of Ukraine. The apostille serves as verification of the documents' authenticity. This work is carried out by the Information and Image Center of the Ministry of Education and Science of Ukraine, which has been given this task in Ukraine.

Language:

Documents stating language proficiency in English. You may document proficiency in English in one of the following ways:

- Completed and passed English course (140 hours per year / 5 hours per week) taken at Norwegian upper secondary school.
- TOEFL (Test of English as a Foreign Language) with a minimum score of 550 on the written test or 80(20/20/20) on the online test.
- IELTS (International English Language Testing System) with a minimum score of 6.5.
- University of Cambridge First Certificate in English OR Certificate in Advanced English OR Certificate of Proficiency in English
